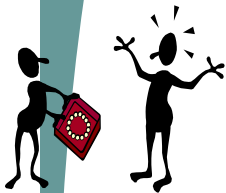

United Way Contributions

According to the United Way, the recommended donation amount is one hours wage per month, which can be divided and taken out of each pay check a month. The donations are tax deductible and can be claimed on your tax returns as charitable donations. All of the money given to the Newton County United Way stays in Newton County.

Hurricane Katrina – After the Storm

It is obvious, now looking back at what has happened to the inhabitants of Louisiana, Mississippi, and Alabama, that Hurricane Katrina will go down as the costliest, natural disaster in American history. However, it is not until you get to look people in the eye who have lost everything; possessions, homes, jobs, even family members that the actual extent of what happened hits home. Over the past two weeks, I have had the opportunity to meet many of these poor souls. Some of whom appear to have simply given up on life, some of whom display great tenacity and determination to make a better life for themselves. Then there are those people who had nothing before the storm, are now getting things for free they could

never afforded previously and see no reason to put forth any effort to change anything, after all why ruin a free ride?? Unfortunately, I also learned that people will not be denied when they want to do a good deed. I cannot even begin to count the number of times people who wanted to donate to the evacuees became incredibly hostile when told they couldn't donate their items at the camp. Some of these "do-gooders" actually got in to very aggravated arguments with those at the front gate. On a couple of occasions they literally had to be taken to the warehouse and shown just

how much the building was overflowing before they could be convinced that we were not rejecting their items because 'they' brought them but because we had no room for the stuff. I wish I could explain the things that some of the evacuees described about their experiences, some of them described entire city blocks disappearing under a wall of water. Others who lived farther inland described unbelievably powerful winds that uprooted trees, demolished buildings and hurled cars and trucks incredible distances. Most people will never know what these people have gone through. At times, I do find it easy to complain about the opportunities the evacuees are being given on a silver platter while others work and work but

Poker Run

We are currently in the process of planning a "Poker Run" as a fundraiser for our third year participating in the Relay for Life; the Poker Run will be held on Saturday, October 22, 2005. Erin and I decided to do a motorcycle event after we helped with the Ride for Matt Gunnin and Family last year; we had a good time and they raised a lot of money! Mike Smith suggested a Poker Run instead of a ride, because it involves more rider participation.

A Poker Run is an independent ride not a guided ride. There is a designated starting and stopping point and

time for everyone. The ride is mapped out and there are set places or "stops" that each rider must go to along the way. During the ride, everyone gets a poker card with five boxes. At each designated point, the riders are dealt a card and a volunteer marks the rider's poker card. The poker hands are judged and the rider with the highest and lowest hand winning a prize at the end.

Right now, we know the Poker Run is going to begin and end at Mickey Dee's in the Covington Crossing Shopping Center. This is a pivotal part of the planning process, Mike Smith and

The car then turned right onto Chaney Drive as Shane followed the car, we saw the driver open the door and get ready to run on foot. Doug and I went down Peoples Street and turned onto Puckett Street. Doug then left me, all by myself, in the patrol car as he and Shane went 10-80 on foot. Well, somewhere along the way, they lost the perp. When I was sitting in the car, a male ran in front of it. I was about to get a description of the male but Sgt. Arvo Bowen, 204 beat me to it. When I heard the description of the male, I hopped on the radio and told 245 that the male had just run in front of his vehicle. Doug then got on his portable radio and told everybody the street he was running towards. About five seconds later, I saw Doug running back to the car, we then searched the area that I saw the male in but did not find him. After all that hard work and adrenaline running through the officers and myself, he still got away. I could tell the frustration they had because I had it in myself also. It was disappointing but those who run away live to be caught another day. I had a lot of fun on my ride-a-long.

still never get so far. I have to remind myself that they have gone through hell, in some fashion, and to some extent different for each one of them – but still their own private hell.

I think the most important thing I take away from this experience is this: all this time the people I have helped have been mere voices without any substance. Sometimes an irritation that went away as soon as I hung up the phone, they were always somebody else’s problem whether they needed a deputy, a police officer, the fire department, or an ambulance – when the line disconnected, I forgot about them and

moved on. The people who call 911 are real, with families and lives of their own, bills to pay, jobs to go to, a real life that has gone horribly wrong for some reason, and they have had to call 911. The people who are now leaving the FFA Camp are real, they have their own problems, they are not just something that can be forgotten when the phone is hung up. I can only hope that nothing like Katrina ever happens here, I do not ever want to be that voice on the other end of the phone line.

10 Georgia Agencies Share CAD

Ten public safety agencies in Newton County, Ga., purchased a \$1.6 million integrated public safety software package from Spillman Technologies featuring CAD, records management, fire/EMS management, mobile communications, and resource management capabilities. The system, acquired through a special sales tax approved by local voters, will enable the agencies to share data across the county and access information from federal and state databases. The Covington-Newton County 911 Communications Center will house the main server for the system, which will be maintained by a full-time system administrator.

- This **street** is in the city the name also can be used at war time
- This **drive** has many different names that can sometimes be confusing, but it doubles as a mascot for a high school
- There is a business that backs up to this, has an address using it, however it faces Hwy 142/Hazelbrand Rd.
- This **road** is in the east and runs off Poplar Hill Rd
